3.	Bidding will be conducted through open competitive bidding procedures using a nor discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules an Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procuremen Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations wit at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the
	Philippines, and to citizens or organizations of a country the laws or regulations of which gran similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183.
