	Republic Act 9184 (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, ccoperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stoc belonging to citizens of the Philippines.
