



1.	<p>The CITY GOVERNMENT OF CALAMBA through the Special Education Fund intends to apply the sum of PHP 18,199,626.73 being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p style="text-align: center;">I-2022-026 Construction of 4 Storey 8 Classroom School Building, Mapagong Elementary School/Barangay Mapagong</p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within Two hundred twenty (220) calendar day/s. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on August 12, 2022 to August 31, 2022 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on August 19, 2022 at 10:00 AM at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
7.	<p>Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 AM August 31, 2022 Late bids shall not be accepted.</p>
8.	<p>All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.</p>
