5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on <b>December 9, 2022</b> to <b>December 28, 2022</b> from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the <b>amount of Php5,000.00</b>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on <b>December 16, 2022 at 10:00 AM</b> at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
7.	<p>Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before <b>9:00 AM December 28, 2022</b>. Late bids shall not be accepted.</p>
