

2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <b>Eighty (80) calendar day/s</b>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "<i>pass/fail</i>" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be acquired by Interested Bidders or his duly authorized representative on <b>December 9, 2022</b> to <b>December 28, 2022</b> from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the <b>amount of Php5,000.00</b>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on <b>December 16, 2022 at 10:00 AM</b> at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
