The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on December 16, 2022 at 10:00 AM at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
7.	<p>Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 AM December 28, 2022 Late bids shall not be accepted.</p>
8.	<p>All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.</p>


