4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>	
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in amount of Php5,000.00.</p>
