5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on October 21, 2022 to November 9, 2022 from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on October 28, 2022 at 10:00 AM at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
7.	<p>Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 AM November 9, 2022. Late bids shall not be accepted.</p>
8.	<p>All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.</p>
